FIRE DEPARTMENT – Fire Chief Kelly Layne reported that the department raised \$1060.00 from the roadblock for Breast Cancer. They will be having a Haunted House to raise funds for the department on Halloween night. The trucks are being repaired. Kelly wanted to state that his injuries were from an

All equipment and electric will be brand new and the warranties will start with the new parts. As far as the tanker is concerned it was bleached and there is no contamination. The same process was done in 2007 during the drought. Our main concern is that the plant is running ok. Everyone is working together and if a citizen has a concern the council will do all that it can to help them understand the process.

Mayor Nixon gave the calendar of events.


Mr. John Knost asked if the sand plant on Wells Road had been approved and had their permits. Alderman Orr explained that no formal request has been sent to the Planning Commission.


