Mayor Maloof called the meeting to order at 5:00 pm. The prayer was offered by Alderman Sargent and the pledge of allegiance was offered by Alderman Wilson. CITIZENS HEARING

Mr. Dean Lay discussed the denial of the Dollar General in a C-3 zone. He said that City Hall was in violation because it is not in the right zone. Why is the planning commission telling property owners what they can do with their property. He stated that the

planning commission can't make a decision on anything that is brought before them. Alderman Favaloro stated that we need a healthy growth plan and Alderman Parmley stated she did not want another Dollar General.

MAYOR

The next City meeting will be June 24, 2024. The planning commission meeting for June has been canceled. There will be a Memorial Day event at the Fire Hall May 27th. There will be a car show at Big Foot this weekend so traffic will be heavy. He wanted to thank Alderman Parmley for putting the flags and crosses up. Police and Fire as well as the Water plant are doing a lot of work and doing a great job.

STREET DEPARTMENT

Mr. Keith Butner reported that the flags are up and Sparkle week went well.

POLICE DEPARTMENT

Chief Raline gave his report. He thanked the Grundy County Sheriff's department for the help with a case in Monteagle.

FIRE DEPARTMENT

Chief Lawyer gave his report. He is working of the CDBG grant that the department has received. He is also working of Emergency Operations Plans for city departments.

CODES

They have one case for City Court.

BUILDING INSPECTIONS

He has done four inspections, two building permits and one residential property that may be unsafe.

The Fire Department lost a firefighter in an accident. They want to thank everyone for the support for the family.

PARKS & REC

Alderman Wilson discussed grants that they can get for tree planting. We need to have a Tree Board. This is for State funding and is a 50/50 match, but hours can count as match. This is a three-year program and there may be classes to train people on how to take care of the trees. Alderman Wilson moved to make the Beautification board be the Tree Board. This will have no impact to private property. Alderman Favaloro seconded the motion and it passed 5/0.

ALDERMAN

Alderman Wilson thanked everyone who came out for the AIA meetings. He asked about the I & I contract and was told that Travis Wilson is working on it.

SECOND READING OF ORDINANCE 05-24 AN ORDINANCE TO REGULATE THE PARKING OF MOTOR VEHICLES ON PUBLIC STRETS AND ROADS. Alderman Parmley moved to approve this ordinance on second reading. Alderman Wilson seconded the motion and it passed 5/0.

SECOND READING OF ORDINANCE 06-24 A BUDGET AMENDMENT FOR THE FIRE GRANT. Alderman Sargent moved to approve this ordinance on second reading. Alderman Wilson seconded the motion and passed 5/0.

SECOND READING OF ORDINANCE 07-24 AN ORDINANCE ESTABLISHING AND IMPLEMENTING A PROGRAM TO CHARGE MITIGATION RATES FOR DEPLOYMENT OF EMERGENCY AND NON-EMERGENCY RESPONSES OF THE FIRE DEPARTMENT TO MOTOR VEHICLE ACCIDENTS. Alderman Wilson moved to approve this ordinance on second reading. Alderman Sargent seconded the motion and it passed 5/0.

NEW BUSINESS

FIRST READING OF ORDINANCE 08-24 AN ORDINANCE TO AMEND SECTION 531 RECREATION VEHICLES. Alderman Wilson moved to approve this ordinance on first reading. Alderman Sargent seconded the motion and it passed 5/0.

FIRST READING OF ORDINANCE 09-24 TO AMEND THE BUDGET FOR YEAR END ADJUSTMENTS. Alderman Wilson moved to approve this ordinance on first reading. Alderman Parmley seconded the motion and on roll call vote passed 5/0.

FIRE DEPARTMENT

Chief Travis Lawyer gave his report. The new Cascade system is in place. They have been working on fire hydrants and they used 18,000 gallons of water this month.

BUILDING INSPECTIONS

There have been 6 inspections, 2 permits and assisted on 2 site plans.

CODES ENFORCEMENT

Mr. A J Wade reported that there was 1 follow up for illegal RV living in town and 1 new complaint that is under review.

PARKS & RECREATION

Ms. Martha Ann gave a report that there are two projects for this year. One is the Christmas tree lighting of 20 trees that will be turned on the day after Thanksgiving. The second is the New Sign at the Monteagle School. She and Iva Michelle are working on the Master Blast as well. Please get your email addresses to them.

STREETS

Mayor Maloof commented on Payne Ave. We will find out our boundaries.

PLANNING COMMISSION

The Dollar General withdrew their application to the BZA so there was no meeting. There will be a workshop on July 2nd and a regular meeting following the workshop.

ALDERMAN

Alderman Parmley asked about the condo's on Moffat Street. They are ready to go and do not have to go back to the planning commission.

Alderman Favaloro asked about the new hotels and Dubose.

Alderman Sargent wanted to commend the Police & Fire Departments. He stated that the I & I project is moving forward.
